#### **Social Committee:**

#### **Finance Committee:**

As we move into the time of year when we to plan for the 2023/24 budget, we begin to contemplate next year's Monthly Assessment, better known as the Condo Fee. Because we are in an inflationary economy (for the first time in decades), it is very likely that next year's condo fees will reflect recent increases in our expenses.

In the recent Quarterly Open Meeting, our two-tiered condo fee structure was mentioned. The condo fee is determined by a somewhat complex formula spelled out in our bylaws; the upshot is that one-bedroom units (including one bedroom/dens) are assessed at a different rate than twobedroom units (including townhouses). While inequities of this arrangement have been debated for many years, the reality is that making a change in our condo fee structure requires amending our bylaws, which requires approval of the majority of members of the Association. Anyone who has served on the Board or committees knows that it is a herculean task to persuade the majority of our unit owners to agree on anything at all. Thus, the formula by which our condo fees are determined has not changed since Old Forge Crossing converted from apartments to condominiums in 1981.



#### Tree Committee:

The Tree Committee has not met for the last two months, so there isn't much to report other than Willow Tree completed removal and pruning for the budget year. The next meeting of the Tree Committee will be on February 21st. Anyone having any comments or questions you would like addressed, please send to the office for the committee to review.





#### **Town Watch**

Town Watch is the eyes and ears of our community, they exist to observe and report, a small number of volunteers patrol the development nightly and if they see anything that does not look quite right, they contact the police, they do not engage, they have no authority to stop or correct a situation and they are never in harm's way, they call 911, just as anyone should if there is a situation. Also, if police are called, notify the office, they should be informed of any incident. Here at Old Forge Crossing our Town Watch provides us another layer of security.

That said, we can really use additional Town Watch patrollers, if you are interested, the contact info is below. It only requires an hour a week of your time and really is a deterrent for potential crimes to our property. All of us like the idea of living in a secure environment, so get involved to make sure it continues, both owners and renters are welcome to join. No previous experience necessary! Training will be supplied.

Make sure you have a fully charged fire extinguisher in your unit. The benefits truly outweigh any cost.

There are no assigned parking spaces at OFC, including the Handicapped spots. Please be aware that anyone with a hang tag, placard or handicapped license can park in any of those spaces, they are not assigned to a specific unit, any questions, please call the OFC office (610) 687-5675

All vehicles must be registered with the office, especially in a snow situation, this info is critical. They need the make, model, color, year and license plate number.

#### **Garbage Disposal Etiquette**

Never put grease in a garbage disposal as it will eventually solidify and clog some or all of the drain. Additionally, items like bones, rice, pasta or pits or seeds from fruits and vegetables can all cause back ups in the drain. Please help us avoid major backups and be mindful of what is going down your kitchen sink.



#### Gas Bills

Please remember that our contracted rate with our supplier expired as of December 31, 2021. What this means is that when you receive your bill for January usage (billed to you in March), your bill will reflect a new billing rate for gas consumption. Due to inflationary costs, the new contracted rate has increased from \$4.098/ Dth to \$8.48930/ MMBtu. We are working with our broker to see what we can do to obtain a lower blended rate now that prices have started to come down. Further information will be communicated to the community once we obtain more information. Please be prepared for the increase in your gas bill! If you have any questions or want additional information, please contact the management office.

#### **Sewer Billbacks**

As a reminder, the 2022 sewer charge from Tredyffrin Township will be assessed against all owner accounts on March 1st, 2023. The fee has remained the same at \$250.00 per home. As a reminder if you are signed up for ACH payments, the sewer fee will be automatically deducted with your monthly assessment. If you are signed up for e-check, you will need to submit an additional payment for your sewer bill.



#### Water Conservation

Everyone Did you know that the average leaky toilet can waste about 200 gallons of water per day? That's over 6,000 gallons a month just for one leaking toilet! Some toilets may produce a running water sound that is easy to hear- if you hear your toilet continuously running, call a plumber to have it repaired and help lower water consumption at Old Forge.

### this MONTH in history

**February 1, 2003** - Sixteen minutes before it was scheduled to land, the Space Shuttle *Columbia* broke apart in flight over west Texas, killing all seven crew members.

**February 2, 1848** - The war between the U.S. and Mexico ended with the signing of the Treaty of Guadalupe Hidalgo. In exchange for \$15 million, the U.S. acquired the areas encompassing parts or all of present day California, Nevada, Utah, Arizona, New Mexico, Colorado, Wyoming, and Texas.

**February 3, 1870** - The 15th Amendment to the U.S. Constitution was ratified, guaranteeing the right of citizens to vote, regardless of race, color, or previous condition of servitude.

**February 6, 1933** - The 20th Amendment to the U.S. Constitution was adopted. It set the date for the Presidential Inauguration as January 20th, instead of the old date of March 4th.

**February 8, 1910** - The Boy Scouts of America was founded by William Boyce in Washington, D.C., modeled after the British Boy Scouts.

**February 11, 1990** - In South Africa, Nelson Mandela, at age 71, was released from prison after serving 27 years of a life sentence on charges of attempting to overthrow the apartheid government.

**February 14, 1849** - Photographer Mathew Brady took the first photograph of a U.S. President in office, James Polk.

**February 20, 1962** - Astronaut John Glenn became the first American launched into orbit. Traveling aboard the "Friendship 7" spacecraft, Glenn reached an altitude of 162 miles (260 kilometers) and completed three orbits in a flight lasting just under five hours.

**February 27, 1950** - The 22nd Amendment to the U.S. Constitution was ratified, limiting the president to two terms or a maximum of ten years in office.

### J FACTS ABO DYFFRIN TOWNSF THE BEGINNINGS ~

Few townships in Pennsylvania are as rich in history as Tredyffrin Township, which is located at the easternmost edge of Chester County, Pennsylvania. In the center of the Township lies the rich and fertile Great Valley, beginning at Valley Forge and running west toward Coatesville.

The earliest settlers were Welsh, and to them, the Township owes its name. Ten or Tre is the Welsh word for town or township, and Dyffrin means a wide cultivated valley; from these words comes the compound tre (tree) dyffryn (valley), or Tredyffrin, meaning a township in a wide cultivated valley.

The Township had its beginning in 1682 when a group of Welsh Quakers went to William Penn in England and purchased, at a price of ten cents an acre, forty thousand acres of land in southeastern Pennsylvania. Penn promised the Quakers that here they could enjoy their customs and language in a little "barony" of their own. This land was originally known as the Welsh Tract and included within its boundaries parts of nine subsequent townships in four counties.

By 1707, Tredyffrin's population was large enough for it to be incorporated as a township. After they had cleared their land and established farms, the most pressing requirements for the early settlers became a mill to grind grain, a meetinghouse for their spiritual needs, and a market where they could sell produce. An example of meeting these needs was the construction of the Great Valley Mill, one of Tredyffrin's first mills. It was in operation by 1710, possibly even earlier, and was built by Thomas Jarman, a noted preacher and miller, on 300 acres of land by Valley Creek (it is now located on North Valley Road in Malvern).






