

Committee Report Highlights



Finance Committee:

Old Forge Crossing has had the fiscal discipline to accumulate a relatively large Reserve Fund, a portion of which we historically have invested in Certificate of Deposits (CDs). CD's are a safe investment with no downside risk although the return on investment is somewhat modest. For the past several years, CD rates have been so low that the OFC Board and Finance Committee have chosen not to reinvest CD's that have reached maturity. Now the interest rates in short term CD's have improved and on the recommendation of the Finance Committee, the OFC board has moved to invest a portion of our reserves in three, six and nine month CDs. These investments lock up our funds for a the term of the CD and a portion of our our reserves needs to remain liquid in order to address upcoming cash needs. The Finance Committee meets on the fourth Tuesday of the month in the Clubhouse and welcomes all interested residents and owners to attend our meetings.



Tree Committee:

The Tree Committee met for the first time this year and was joined by manager, Jennifer McLaughlin. The annual calendar was reviewed for both tree maintenance and tree care which will continue to be worked on in the coming months. It was noted that we now have more than 50 new plantings around the property and tree care will need to be a focus this spring and summer. Our maintenance team have been doing a great job spreading tree chippings from recent removals along the sound wall for weed control and clean up. It's looking great and we thank Tony and Kurt for all of their efforts. The Ad-Hoc committee members found it helpful to include Jennifer in this month's meeting for planning and information purposes. They have expressed an interest in continuing to meet earlier so management has the ability to attend as needed and available. The committee discussed and voted on Emily Bell taking over as chairperson for the Tree Committee and Kathy Durkin will temporally act as committee secretary until a member is added.

Not positive if it is due to mischief or the construction/ maintenance going on around our property. OFC LECTURE Featuring OFC resident Kyle Bryant




In 1997, when Kyle was just 17, he was diagnosed with Friedreich's ataxia (FA) - a debilitating, life-shortening, degenerative neuromuscular disorder. To raise money for FA research, in 2007 Kyle and his family rode bikes 2500 miles from San Diego, CA to Memphis, TN. This was the first of several long-distance rides with which they raised a combined total of over \$400,000. In 2009, Kyle became a staff member of the Friedreich's Ataxia Research Alliance (FARA); together, they built a nationwide series of single day, family friendly rides and to date have raised \$11 million.

OF THE MONTH LEMON SCONES PREHEAT OVEN TO 425

INGREDIENTS

FOR SCONES

Finely grate zest of 3 lemons 1/2 C sugar 3 C all-purpose flour 1 TBL baking powder 1/2 tsp kosher salt 1/4 tsp baking soda 1 C unsalted cold butter, cut into 1/2 inch cubes 1 large egg, cold 2/3 C buttermilk, plus extra for brushing scones

FOR LEMON GLAZE

1/2 C powdered sugar 2 TBL lemon juice LINE BAKING SHEET WITH PARCHMENT PAPER | MAKES 8 SCONES

In large bowl, use fingertips to rub lemon zest into sugar, infusing sugar with the oils from lemon zest. Whisk in the flour, baking powder, salt and baking soda.
 Using a pastry cutter or 2 knives, work the butter into the flour mixture until the

mixture forms coarse crumbs and the butter pieces are no larger than a pea.
 Measure the buttermilk in a liquid measuring cup, whisk in egg. Pour the butter-

Measure the buttermilk in a liquid measuring cup, whisk in egg. Pour the buttermilk mixture into the flour mixture. Gently fold mixture together with a rubber spatula until if forms a cohesive, but crumbly mass. **Don't overmix**! It's OK if the dough is slightly lumpy or a few dry bits remain.

♦ Transfer the dough to a lightly floured surface. Use hands to gently knead the dough a few times, then press the dough into an 8" diameter disk about 1-1/2" thick. Use a long knife, cut the disk into 8 equal sized wedges. Place wedges on prepared baking sheet about 1" apart. Use pastry brush to lightly brush the tops of scones with buttermilk. **PLACE TRAY IN FREEZER AND CHILL FOR 15 MIN**.

 Bake scones in center of the oven for about 20 minutes (until golden on top and browned underneath). Allow to completely cool before drizzling on glaze.

♦ MAKE LEMON GLAZE by whisking together powdered sugar and lemon juice until smooth. Use a spoon to drizzle the cooled down scones with the lemon glaze. Allow to sit for 10 minutes before serving.

Scones will keep in airtight container for 2 days. For longer storage, they can be frozen for up to 2 months in freezer bag. Thaw for 1 hour before eating.



this MONTH in history

March 1, 1961 - President John F. Kennedy established the Peace Corps, an organization sending young American volunteers to developing countries to assist with health care, education and other basic human needs.

March 4, 1789 - The first meeting of the new Congress under the new U.S. Constitution took place in New York City.

March 10, 1880 - The Salvation Army was founded in the United States. The social service organization was first founded in England by William Booth and operates today in 90 countries.

March 17, 1776 - Early in the American Revolutionary War the British completed their evacuation of Boston following a successful siege conducted by Patriots. The event is still commemorated in Boston as Evacuation Day.

March 21, 1943 - A suicide/assassination plot by German Army officers against Hitler failed as the conspirators were unable to locate a short fuse for the bomb which was to be carried in the coat pocket of General von Gersdorff to ceremonies Hitler was attending.

March 23, 1775 - Patrick Henry ignited the American Revolution with a speech before the Virginia convention in Richmond, stating, "I know not what course others may take; but as for me, give me liberty, or give me death!".

March 24, 1989 - One of the largest oil spills in U.S. history occurred as the oil tanker *Exxon Valdez* ran aground in Prince William Sound off Alaska, resulting in 11 million gallons of oil leaking into the natural habitat over a stretch of 45 miles.

March 26, 1979 - The Camp David Accord ended 30 years of warfare between Israel and Egypt.

March 31, 1933 - The Civilian Conservation Corps, the CCC, was founded. Unemployed men and youths were organized into quasi-military formations and worked outdoors in national parks and forests.

UN FACTS ABOU DYFFRIN TOWNSHIP TREDYFFRIN AND THE AMERCIAN REVOLUTION ~

During the American Revolution, the British army was encamped along the south side of Swedesford Road between Howellville and New Centerville. Sir William Howe, British commander in chief, made his headquarters at the home of Samuel Jones on the corner of Contention Lane and Old State Road. Lord Cornwallis, who succeeded Howe as commander in chief, made his quarters at the Reese homestead on Cassatt Road.

A few months later, the American Army arrived in Tredyffrin for a winter encampment at Valley Forge from December 1777 to June 1778. Many of Washington's generals made their quarters in the homes of Tredyffrin farmers during that winter. Generals Lafayette and DuPortail were in the homes of Samuel and John Havard. Generals Lee and Bradford stayed with David Havard in a house still standing in Chesterbrook. Lord Stirling lived with Reverend William Currie on Yellow Springs Road in what is now Valley Forge National Historic Park. Wayne's Quarters were in the home of his cousins, Mr. and Mrs. Joseph Walker on Walker Road, while General Pulaski was across the road with the Beaver family on Brookmead Farm. Many of these houses still stand and are listed historic sites in the Township.






