Finance Committee (Dave Inman)

In our recent annual meeting, the Condominium Association voted down a proposal to amend the bylaws. The amendment would have authorized the executive board to borrow up to \$250,000 without the approval of the majority of the unit owners. The current borrowing limit is \$50,000. The motivation for proposing this change was to give the board the latitude to obtain a loan quickly if there were some extraordinary circumstances that required such an action. However, let me emphasize that the association has not applied for a loan. Indeed, with our substantial reserves, there is no reason to take out a loan and pay interest. At any rate, the change was not approved and our bylaws remain the same.

The Finance Committee meets on the fourth Tuesday of the month in the Clubhouse and welcomes all interested residents and owners to attend our meetings.



Social Committee (Bill Lobo)

April was relatively slow month for events, but we are looking forward to a busy Spring and Summer. The Social Committee will be hosting a Cinco de Mayo Happy Hour on May 5th in the Clubhouse at 5:00 PM and the pool opening and Memorial Day Barbecue on May 27th at 1:00 PM. New Resolution Approved: Rules and Regulations Update

Over the past several months the Old Forge Crossing Board has been discussing rules and regulations around both pets and emotional support animals in the community. As a result, on March 14th, 2023, a resolution was passed to Section VIII, Pets and Wildlife.

This resolution will allow us to better regulate pets and emotional support animals at Old Forge Crossing with clearly defined regulations. As part of this resolution, we are implementing the Poo Prints DNA Program to help reduce pet waste on the grounds of the community.

All residents with Emotional Support/Service dogs will be contacted in the upcoming weeks to schedule a time to come in and swab their dogs cheeks for a DNA sample that will be registered with the World Pet Registry (WPR). Once registered, dog waste that is not picked up around the community can be traced back to the responsible resident for proper fine enforcement.

Improvements and betterments are considered to be any improvement a unit owner makes to their unit after purchase that improves its value. Betterments and improvements are typically new fixtures, alterations, or installations. In the event of a claim with the Association, OFC's policy does not afford coverage for these things. Protect your investments and call your insurance agent to make sure you have this added to your policy.

1 LB asparagus, thick ends trimmed

1/2 tsp salt, divided, plus more to taste

1/2 medium onion, finely chopped

5 - 6 C chicken or vegetable stock

1/2 C finely grated Parmesan, plus

1 TBL finely grated lemon zest

1/4 C extra virgin olive oil

1 TBL balsamic glaze

1 C peas, fresh or frozen

2 C Arborio rice

2 TBL lemon juice

OF THE MONTH

RISOTTO W/ BALSAMIC-ROASTED ASPARAGUS AND PEAS

INGREDIENTS SERVES 4-6 | PREP TIME 10 MIN | COOK TIME 30 MIN

- Preheat oven to 400 degrees; Line a rimmed baking sheet with parchment paper
- ♦ Using vegetable peeler and starting about 3" below the tip working toward end, peel away thin outer layer of each asparagus spear. Lay spears on baking sheet and drizzle with 2 TBL olive oil and 1/8 tsp of salt. Toss to coat with 2 TBL olive oil and spread in nice even row.

Roast asparagus for 10 minutes or until tender. Drizzle with balsamic glaze. When cool enough to handle, cut spears into 1" pieces and set aside.

- ♦ In 4 quart saucepan, over medium-low heat, warm the remaining 2 TBL olive oil. Add onions and 1/8 tsp salt. Cook, stirring often for 4 -5 minutes or until onions are soft and translucent.
- Add rice to onions and cook, stirring for 2 minutes, or until the grains are warm and coated with oil.
- Add 2 cups of stock to the pot with rice and set heat so it maintains a steady simmer. When stock is mostly absorbed, continue to add stock in 1/2 cup increments, stirring regularly until it's almost absorbed, about 20 25 min.

The rice should look like shiny porridge and should be slightly *al dente*, but err on side of undercooking, since it will continue to cook and absorb liquid off the heat. Taste and add more salt if needed.

- ♦ Towards the end of cooking, stir in peas and cook for 2 3 min. Add the asparagus and stir over heat until warm.
- Remove pan from heat. Stir in lemon zest, lemon juice and Parmesan. Serve in bowls with Parmesan, if you like.

May 2, 2011 - U.S. Special Operations Forces killed Osama bin Laden during a raid on his secret compound in Abbottabad, Pakistan.

May 5, 1893 - The Wall Street Crash of 1893 began as stock prices fell dramatically. By the end of the year, 600 banks closed and several big railroads were in receivership.

May 7, 1945 - In a small red brick schoolhouse in Reims, Germany, General Alfred Jodl signed the unconditional surrender of all German fighting forces thus ending World War II in Europe.

May 10, 1869 - The newly constructed tracks of the Union Pacific and Central Pacific railways were first linked at Promontory Point, Utah.

May 12, 1937 - George VI was crowned at Westminster Abbey in London, following the abdication of his brother, Edward VIII.

May 14, 1804 - Meriwether Lewis and William Clark departed St. Louis on their expedition to explore the Northwest.

May 27, 1937 - In San Francisco, 200,000 people celebrated the grand opening of the Golden Gate Bridge by strolling across it.

May 29, 1787 - At the Constitutional Convention in Philadelphia the Virginia Plan was proposed calling for a new government consisting of a legislature with two houses, an executive chosen by the legislature and a judicial branch.

May 30, 1783 - The Pennsylvania Evening Post became the first daily newspaper published in America.

May 31, 1889 - Over 2,300 persons were killed in the Johnstown flood in Pennsylvania.

St. Peter's Church in the Great Valley - Taken by an unknown photographer soon after the Civil War, St. Peter's Church in the Great Valley was originally part of a Church of England parish founded in 1700, and is today the oldest Episcopal church in Chester County. The present church building, built in 1744, is located in a rural setting astride Tredyffrin Township and East Whiteland Township off of Church Road.

2023 OFC POOL RULES & REGULATIONS

2023 POOL HOURS

May 27, 2023 — July 31, 2023 Monday - Sunday 11:00 AM to 8:00 PM

Monday - Sunday 10:30 AM to 7:30 PM

August 1, 2023-September 19, 2023

POOL BADGES

- In accordance with the Occupancy Rules, two badges will be issued to one-bedroom units; two badges will be issued to two-bedroom units, with two additional badges available upon written request to the management office from the Unit Owner.
- Lost badges will be replaced at a charge of \$25.00 each.
- Badges must be displayed prominently while on the pool property.
- Owners and/or their Tenants will be denied pool badges for any outstanding delinquencies (e.g., condo fee, gas bill, etc.).
- A fine \$50.00 and seasonal loss of pool privileges will occur if pool badges are loaned, given, or sold from one resident to another resident in a different Old Forge Condominium unit.
- A fine of \$100.00 and lifetime loss of pool privileges will occur if pool badges are loaned, given or sold to non residents of Old Forge Crossing.
- Repeated infractions or disregard of the pool rules and regulations will result in fines and/or loss of pool privileges.

ADMITTANCE PROCEDURES

- Sign the daily register upon arrival.
- Admittance to the pool is allowed only during pool hours. Signage will be posted if the pool is Swim-at-Your-Own-Risk.
- No children under the age of 14, regardless of swimming ability, will be admitted to the pool area without an accompanying parent or guardian.
- All infants must wear swim diapers.
- The lifeguard has the authority to refuse admittance to persons who, in his/her determination, are unfit to swim or for reasons of health, intoxication, dress or unruly behavior.

GENERAL RULES & REGULATIONS

- All persons must obey the pool rules and the instructions of the lifeguard at all times.
- No smoking is permitted inside the fenced pool area.
- No glass is permitted in the fenced pool area
- All persons on the pool deck and/or swimming in the pool must have on proper swim attire. All infants/toddlers that require a diaper must wear swimmer diapers and proper swimwear.
- All non-swimming children must have a parent or guardian in the pool within three (3) feet, and are restricted to the shallow end. To qualify as a swimmer the lifeguard will administer a swim test.
- Diving, running, pushing, dunking, and horseplay are prohibited. Playing in the pool is permitted at the discretion of the lifeguard.
- Rafts and other flotation devices are not permitted in the pool with the exception of noodles. Water wings are not permitted unless closely supervised (1 adult with 1 child).
- Music and voices must be at a volume which will not disturb other residents.
- Pets are not permitted in the pool area, with the exception of service animals.
- Do not enter the pool with an open wound.
- Do not block the lifeguard's view of the pool.
- Patrons are not to visit or engage in unnecessary conversation with lifeguards while they are on duty.


